## Resolution Number: L -83-43

WHEREAS, a petition has been filed with the Executive Officer of the El Dorado County Local Agency Formation Commission to form the GOLDEN WEST COMMUNITY SERVICES DISTRICT in the County of El Dorado, and said Executive Officer has examined said petition and executed his certificate determining and certifying that said petition is sufficient; and

WHEREAS, at the times and in the form and manner provided by law, said Executive Officer has given notice of public hearing by this Commission upon said petition; and

WHEREAS, a Negative Declaration has been prepared and filed for public response to this Commission's finding that this formation will have no significant effect on the environment and the time for public response has passed; and

WHEREAS, said Executive Officer has reviewed said petition and prepared a report, including his recommendations thereon, said petition and report having been transmitted to and considered by this Commission; and

WHEREAS, at such hearing this Commission heard and received all oral and written protests, objections and evidence which were made, presented or filed, and all persons resent were given an opportunity to hear and be heard in respect to any matter relating to said petition and report.

NOW, THEREFORE, the Local Agency Formation Commission of the County of El Dorado does HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. Subject to the terms and conditions hereinafter specified, said petition is approved.

Section 2. The boundaries, as set forth in the petition of the territory proposed to be formed, are approved. A description of said boundary is attached hereto marked EXHIBIT "A" and incorporated herein by reference. Said territory is found to be inhabited and said territory is assigned the following distinctive short form designation:

"FORMATION NUMBER F-83-05 (GOLDEN WEST COMMUNITY SERVICES DISTRICT)"

Section 3. BE IT FURTHER RESOLVED, that effective upon the formation of the District, said District's sphere of influence shall be as outlined on the map marked EXHIBIT "A".

Section 4. Any resolution ordering such formation shall provide that such formation shall be made subject to the terms and conditions contained in said petition and subject to the following: that the District pay the LAFCO and State Board of Equalization fees; that the District is being formed for road and maintenance purposes only and that any additional services to be added by the District should be approved by LAFCO; the oplication is to be sent to the Board of Supervisors for determination regarding he formation; and the Board of Supervisors will supply LAFCO with two (2) certified copies of their resolution of determination on their hearings; and that a Negative Declaration on this project is to be filed and accepted.

Section 5. The Board of Supervisors of El Dorado County is designated as the conducting authority and the proponents of the proposed District are hereby authorized to initiate formation proceedings by petition to the Board of Supervisors pursuant to Community Services District Law (Government Code Sections 61000. et seq.)

Section 6. Prior to the effective date of this formation, LAFCO, in compliance with the requirements of the Revenue and Taxation Code Section 99 relating to property tax revenues.

Section 7. The Commission having determined that this annexation will have no significant effect on the environment and having approved this formation, the Executive Officer is hereby directed to file a Notice of Determination as prescribed by Section 15083, Title 14, California Administrative Code.

Section 8. The Executive Officer is hereby authorized and directed to mail certified copies of this Resolution in the manner and as provided in Section 56272 of the Government Code.
