# Request for Proposal:

Crystal Blvd Asphalt Overlay Project

North District Boundary (6221 Crystal Blvd) to Obrizo St.

**Date:** April 3,2024

## Scope of Work:

Apply 2" asphalt overlay on Crystal Blvd from the North District Boundary (approx.. 6221 Crystal) to Obrizo St. This is approximately 1.7 lineal miles. This is approximately 215,424 sq/ft. on roadway surface. In addition, there are approx. 54 mailbox turn-outs averaging 75 sq/ft each. There are 84 driveway accesses and 7 side road encroachments to tie into. New overlay to tie into previous overlay at Obrizo St. Replacement of road striping to be included in the proposal. Road striping to consist of yellow reflective painted centerline with installation of reflective buttons and a reflective fog line painted on both sides of the roadway. Road striping and button placement shall be consistent with dimensions as they are Crystal Blvd where the new project will meet existing conditions. The District would like to have options for a reduced scope of work.

### **Location of Work**

The work area will be within the Golden West Community Services District, approximately 4.7 miles South of El Dorado on Highway 49.

### **Description of Work / Proposal:**

The entire work site will be cleaned as required to remove small debris. Recondition / repair any road surface and shoulder areas prior to application of oil. Apply appropriate oil to the entire area once clean. Overlay entire section with 2 inch compacted depth hot asphalt mix rolled smooth. Shoulder backing shall be installed or reconditioned as required. Temporary centerline "flags" shall be placed in preparation for paint.

Note: Most of the proposed project area has a Petromat base under the current surface.

#### **Traffic Control:**

All traffic control shall be the responsibility of the Contractor. This will include the road shall remain open with minor traffic stoppage as needed when mobilizing equipment, materials or workers. Public and worker safety is a priority throughout the project.
