Request for Proposal:

Vertical Clearance Maintenance on GWCSD Roads

April 3, 2024

Description:

Over the years trees that are located within the District Right-of-Way have grown out and over the roadways. We want to restore the overhead/vertical clearance in those Right-of-Ways.

Scope of Work:

Restore a 15 foot vertical height clearance over the roads within the GWCSD. The area of work will include two feet outward of the roadway painted "Fog Line" on each side of the road and back to the centerline.

Location of Work:

The work area will be within the Golden West Community Services District, approx. four miles South of El Dorado on Highway 49.

Description of Work / Proposal:

- A. Attached is a description of the areas of concern along the roads. All trimmings are to be chipped and removed. The clearing of brush, tree branches and small trees (less than 6 inches in diameter) a minimum distance of 2 feet from the outside edge of the paved road surface, on both sides of the roadway. All brush/ small tree removal shall be cut as close to the ground as possible. All tree branches, regardless of size, shall be trimmed, and/or removed to allow a minimum fifteen (15) feet height clearance within the paved width of the roadway.
- B. The condition of the roadway surface varies within the District. Certain areas or roads have portions of the roadway which lack pavement and contain a mix of gravel or dirt surfaces. In these areas the brush and tree removal, as identified in description "A" above, shall extend a minimum distance of 2 feet beyond the travel surface of the road. Brush and tree branches, regardless of size, shall be trimmed and or removed, to allow a minimum fifteen (15) feet height clearance within the road surface.
- C. All materials generated as a result of this process, consisting of but not limited to wood, brush, leaves and trees, shall become the property of the Contractor. These shall be chipped and or otherwise contained and transported off site and properly disposed of by the Contractor at no additional cost to the District.

- D. All work shall be performed incompliance with all applicable Federal, State and Local Codes / Laws and Regulations.
- E. It is the sole responsibility of the Contractor to provide and maintain traffic control measures as required to perform the work in a safe and orderly manner. At no time shall the Contractor close any portion of the road to vehicular traffic with the exception of minor interruptions associated with the falling of a tree branch or "as need brief " clean up of debris.
- F. The Contractor shall provide the District with a schedule of the proposed work activities a minimum of three days prior to start of work.
- G. The Contractor shall provide street signage, alerting the residents of the proposed work, a minimum of three days prior to the start of work. The signage shall be placed in three different locations, as directed by the District representative. The street signage shall be maintained by the Contractor and remain in place during the duration of the work. The size and message on the signs shall be approved by the District prior to placement.

Traffic Control:

All traffic control shall be the responsibility of the Contractor. This will include the road shall remain open with minor traffic stoppage as needed when mobilizing equipment, materials or workers. Public and worker safety is a priority throughout the project.
