Dear Board of Directors,

This letter is to announce my intent to serve on the Board, in the open position with the unexpired term ending December 1, 2017, should the Board, in its discretion, decide to extend that opportunity to me.

Before jumping in to my qualifications, and describing what I may be able to offer the Board and the community, I'd like to briefly introduce myself. My wife and I moved here in May of 2014 after living in the Sacramento area for the past 14 years. community and way of life here weighed heavily in that decision. We registered as voters in the district prior to the June 2014 elections, and began attending Board and Fire Safe Council meetings shortly after the completion of our move. Some will recognize me as an active "member of the public" at Board meetings, where I frequently ask questions and offer ideas for consideration. My wife and I both have an active interest in finding ways to help our neighbors and the community, such as our participation in the recent auction, as well taking part in neighborhood activities, and in seeking ways to maintain the current character of the community. We both see serving on the Board as an opportunity to serve the community.

I'll now move on to my professional experience and skills, which are directly applicable to Board responsibilities and duties. That experience includes over 25 years of working in a Fortune 500 Company, where I've acted in a wide range of management roles of increasing responsibility, in almost every aspect of company operations. Areas of expertise and experience with the most direct application to the Board include Financial Analysis, Vendor Oversight, Contracting, Performance Standards development, and Regulatory and Contractual Compliance. I've created frameworks, structures, processes, and policies and procedures that support efficient and successful operations (both short and long-term).
