5. General Managers Report

- Recent activities
 - 6329 Crystal Drainage Easement Improvement (Joe Vicini, Inc.)
 - Vertical Vegetation Clearance (Hilltop Tree Service, Inc.)-district would like to continue this work next year as budget allows.
 - Crystal Overlay Obrizo +/- 1 M north (Veerkamp Gen'l Eng'g, Inc.). There are still
 a few valve risers that need to be installed to bring valve covers up to grade by
 Veerkamp. Ed will talk with Tom Wilson about striping at intersections.
- Near-term plans
 - o Drainage work Crystal Blvd. (see 2nd New Business item)
- Issues and requests: who updates LAFCO information as to board officers? Info is updated when LAFCO asks for updates.

 Who is CAL-Fire contact person? Ed needs this information and any recent contracts in order to move forward with CAL-Fire/Growlersburg in the future. Generally this contract is a daily rate for a certain size crew.

Director Williams. No report.

Director Stoddard – Financial Officer's Report. We will have a balance of \$250, 157 after the payment of Veerkamp for overlay work. Payment is pending final sign-off on project.

Director Orrick. Norm will ask for volunteers at Fire Safe council Saturday re: board membership and traffic control for CAL-Fire work in the future.

Director Hill. No report. Will discuss signs later.

Director Regelbrugge – Recognitions, IT, 2024 Election, 2025 operations, Decorum review Recognitions-Pat Williams took lead for statements of work; Ed, Stan and Norm came into active Board service and helped us continue work. Thanks to all for their support of district operations. 2024 elections. We need another board member.

2025 operations. We got lots of projects done and there has been good cohesion on the board. We need to continue this positive activity going forward. Once again, thanks to board members and other support folks for keeping the district functioning effectively and legally.

Decorum review. If board members need to be absent from the district and/or meetings, please let president know so that district activities can continue without interruption.

Marc will contact Evergreen Weed Abatement company to clarify terms of the contract for scheduling and billing.

7. Old Business

• **Board Secretary Vacancy** – The Board will discuss the process of engaging a permanent Secretary, will identify any present candidates and may appoint a candidate to serve as Board Secretary should one emerge.

Board discussion/Public comment/Board action

- Pending Projects The Board will discuss planning and potentially authorize projects already under consideration, in work or requiring further definition. The Board may take action as appropriate to further advance these projects:
 - a) Signage replacement: street-name signs, selected traffic signs. Leanne and Joel Borges did lots of work on this and has proposals with costs from several vendors.
 Near term priority should be on street names. Ed is working with both Spot On and Road Tech to get signs produced and installed. Stan and Norm volunteered to help Ed with this effort.
 - b) Vegetation Management within 5 feet of fog line(s). Particularly northbound toward the 49 end of Crystal there is vegetation close to the fog line which limits sight lines. Marc will do flagging on Crystal between now and December to establish work.

c) Encroachments re-paving. This is a low priority relative to other projects above but will be kept on future projects list.

8. New Business

 Conflict of Interest Code Update – The District will issue notice of a 45-day comment period for the proposed Conflict of Interest Code update. The Board may require changes/additions to the proposed update.

Board Discussion/Public Comment/Board Action. Board members should let Marc know within 45 days if they have suggestions for additional updates.

Crystal Drainage Maintenance – The Board will consider scope and authorization/appropriation
for improving drainage facilities in selected locations along Crystal Boulevard. Ed would like to
clean ditch out from south end about 20-30 feet, use underlayment and rip-rap to stabilize hillside
and stop erosion. Would like to get this done before rainy season. Marc would like to include
work at 7240 to shape ditch at crown. Some of the ditches are prohibited by water lines being right
at bottom of ditch.

Board Discussion/Public Comment/Board Action. Marc moved to authorize GM Ed White to let a contract not to exceed \$30,000 for ditch improvement on Crystal. Norm seconded. In summary, this work will include Crystal curve, 7240 Crystal and 7300 Crystal. Approved unanimously.

• 2025 Project Planning – The Board will discuss possible projects to be undertaken through calendar year 2025, and possibly define project scope and priority. The Board may also authorize expenditures for projects to be brought forward by the General Manager, Directors or the public.
